**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That T. L. HICKS**

of Route 1, Box 265, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek a tributary of Springs Valley Creek, a tributary of Willamette River for the purpose of irrigation under Permit No. 16327 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 7, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.120 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Wm. Walker D.L.C. No. 49, Section 19, Township 6 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.2 acres in SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Wm. Walker D.L.C. No. 49  
0.4 acre in NW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Wm. Walker D.L.C. No. 49  
Section 19

Township 6 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Beg. at a point 38.05 chs. N. from the SW cor. of the D.C. of Wellington B. Walker and wife Not. No. 150, Claim No. 49 in T. 6 S., R. 3 W., W. M.; thence N. along the W. line of said Claim 55.50 chs., to the NW cor. of said Claim; thence E. following the N. line of said Claim 27.03 chs., thence S. parallel with the W. line of said Claim, 55.50 chains; thence W. 27.03 chains to the place of beginning and containing 150.01 acres of land more or less, and being a part of the D.C. of W. B. Walker, Section 19 and 30, T. 6 S., R. 3 W., W. M., Polk County, Oregon, and being the same premises conveyed by A. J. Purvine and Pauline Purvine, his wife, to Jordan Purvine by deed dated December 8, 1886, recorded December 22, 1886 at Page 377, Vol. 17, of the public records of Polk County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
