CERTIFICATE OF WATER RIGHT

This Is to Certify, That WALDO FLINT

of Route 1, Beaverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River a tributary of Willamette River for the purpose of

irrigation under Permit No. 16975 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from 120 3. 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 SE1, as projected on Thomas Humphrey D.L.C. No. 39, Section 11, Township 2 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.6 acres in SW_{4}^{1} NE_{4}^{1} , as projected on Thomas Humphrey D. L. C. No. 39 1.0 acres in SE_{4}^{1} NW_{4}^{1} , as projected on Thomas Humphrey D. L. C. No. 39 1.2 acres in NE_{4}^{1} SW_{4}^{2} , as projected on Thomas Humphrey D. L. C. No. 39 4.0 acres in NE_{4}^{1} SE_{4}^{1} , as projected on Thomas Humphrey D. L. C. No. 39 22.2 acres in NW_{4}^{1} SE_{4}^{1} , as projected on Thomas Humphrey D. L. C. No. 39 Section 11

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

From the Northeast Corner of the Thomas D. Humphreys Denation Land Claim No. 39, in Township 2 South, Range 2 West of the Willamette Meridian, run North 78° West along the North line of said Claim 9.22 chains, thence South 35° 51' West 15.85 chains, thence South 33° West 36.86 chains, thence South 49° West 3.87 chains to the place of beginning of the tract herein described, run thence North 49° East 3.87 chains, thence North 33° East 36.86 chains, thence North 35° 51' East 15.85 chains to a stone on the North line of said claim, thence North 78° west along said North line 11 chains, more or less, to the East line of Section 11 of said Township and Range, thence North to the Northeast Corner of said Section 11, thence West along the North line of said Section 11 to its intersection with the North line of said Donation Land Claim No. 39, thence North 78° West along the North line of said Donation Land Claim to a point South 78° East 26.42 chains from the Northwest corner of said Donation Land Claim, thence South 19° 6' West 10.46 chains to a stone, thence South 50° 37' West 5.45 chains, thence South 29° 31' West 2.71 chains to angle in ditch, thence South 17° 6' West 11.49 chains to a stone, thence South 75° 10' East 19.07 chains to a stone, thence South 16° 28'

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
