CERTIFICATE OF WATER RIGHT

This Is to Certify, That JAY W. WRIGHT

of Milo, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River a tributary of _____ for the purpose of irrigation

under Permit No. 17773 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 28, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 34, Township 30 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet for each acre irrigated during the irrigation season of each year, and shall be still further limited to a diversion of not to exceed 0.30 c.f.s.,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.74 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$

17.38 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$
4.19 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 27
2.57 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$
1.62 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 34
Township 30 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

W $\frac{1}{2}$ SW $\frac{1}{4}$ N & W of River less 73.97 a. hwy. in Sec. 26; SE $\frac{1}{4}$ SW $\frac{1}{4}$: NE $\frac{1}{4}$ SE $\frac{1}{4}$: S $\frac{1}{2}$ SE $\frac{1}{4}$ less 0.37 a. hwy. in Section 27; $\frac{1}{2}$ NE $\frac{1}{4}$: NE $\frac{1}{4}$ NW $\frac{1}{4}$: NW $\frac{1}{4}$ NE $\frac{1}{4}$ N in Section 34, all being within Township 30 South, Range 3 West, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
