## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That NEAL W. WILLER

, State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Champoeg Creek and Case Creek a tributary of Willamette River

irrigation

for the purpose of

under Permit No. 14000

of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 3, 1939 for 0.85 c.f.s. and June 11, 1939 for 0.98 c.f.s.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.83 cubic feet per second, being 1.10 c.f.s. from Champoeg Creek and 0.73 c.f.s. from Case Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located marker from Champoeg Creek:  $SN_{4}^{-}$   $NE_{4}^{-}$ , Section 27, as projected on Andrew Bower D.L.C. No. 53; from Case Creek:  $SN_{4}^{-}$   $SE_{4}^{-}$ , Section 26, as projected on Andrew Bower D.L.C. No. 53, all being within Township 4 South, Range

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.8 acres in NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Andrew Bower D.L.C. No. 53 30.8 acres in NW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Andrew Bower D.L.C. No. 53 10.6 acres in SWI SWI, as projected on Andrew Bower D.L.C. No. 53 20.8 acres in SE4 SW4, as projected on Andrew Bower D.L.C. No. 53 0.7 acre in NW4 SE4, as projected on Andrew Bower D.L.C. No. 53 17.0 acres in SW4 SE4, as projected on Andrew Bower D.L.C. No. 53 Section 26 1.3 acres in  $SW_4^1$   $NE_4^1$ , as projected on Andrew Bower D.L.C. No. 53 7.8 acres in SEA NEA, as projected on Andrew Bower D.L.C. No. 53 33.0 acres in NEA SEA, as projected on Andrew Bower D.L.C. No. 53 10.5 acres in NWA SEA, as projected on Andrew Bower D.L.C. No. 53 Section 27 Township 4 South, Range 2 West, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
