CERTIFICATE OF WATER RIGHT

This Is to Certify, That EIMER H. AND ROSE A. MEXER

State of of Route 1, Cornelius Oregon ; has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Fork of Dairy Creek

a tributary of Tualatin River for the purpose of irrigation

under Permit No. 13405 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 19, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEA SEA, as projected in A. Harrison D.L.C. No. 41, Section 4, Township 1 North, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 3.9 acres in SWA SWA, as projected on A. Harrison D.L.C. No. 41 Section 3

> 1.2 acres in NE_{4}^{1} SE_{4}^{1} , as projected on Wm. Wilson D.L.C. No. 37 4.2 acres in NE_{4}^{1} SE_{4}^{1} , as projected on A. Harrison D.L.C. No. 41 34.3 acres in SE_{4}^{1} SE_{4}^{1} , as projected on A. Harrison D.L.C. No. 41

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

A part of the tract of land situate in Sections 3, 4, 9, and 10, Township 1 North, Range 3 West of the Willamette Meridian, in the Archibald M. Harrison Donation Land Claim No. 41, Notification No. 146, and in the William Wilson Donation Land Claim No. 37, Notification No. 167, in Washington County, Oregon, conveyed to the United States of America by Scott E. Campbell et al, by deed recorded January 5, 1937, in Book 161, Page 336, of the Deed Records of Washington County, Oregon, said part being more particularly described as follows, to wit:

Beginning at the Northwest corner of the Archibald M. Harrison Donation Land Claim, said corner being marked by a 12" iron pipe; thence South 78° 31' 59" West for a distance of 35.76 feet to a point on the center line of West Dairy Creek; thence meandering the center line of West Dairy Creek as follows: North 9° 26' 08" West 105.95 feet; North 0° 57' 39" East 115.10 feet; North 32° 13' 46" West 100.25 feet; North 70° 27' 00" West 95.00 feet; thence leaving the center line

of Dairy Creek due South for a distance of 478.60 feet to a point; thence due East for a distance of 194.00 feet to a point; thence South 0° 04° 56" West for a distance of 1991.17 feet to a point; thence North 89° 48° 00" East for a distance of 861.61 feet to a point; thence South 1° 09° 00" West for a distance of 180.00 feet to a point marked by a 3/4" iron pipe; thence South 88° 19° 00" East for a distance of 161.20 feet to a point marked by a 3/4" iron pipe; thence South 1° 46° 00" Feet for a distance of 226.41 feet to a point on the South line of the Archivald M. Harrison Donation Land Claim, said point being referenced by a 3/4" iron pipe set back on line 20.00 feet; thence North 89° 35° 32" East along the South line of the Archibald M. Harrison Donation Land Claim for a distance of 299.26 feet to a point marked by an iron casting.

Thence South 88° 52' 12" East along the South Line of the Archibald M. Harrison Donation Land Claim for a distance of 145.05 feet to a point marked by an iron casting, said point being on the West edge of an old mill race; thence North 1° 59' 27" East along the West edge of an old mill race for a distance of 1394.72 feet to a point marked by a 2" iron pipe; thence North 31° 37' 56" East along the West edge of an old mill race for a distance of 974.97 feet to a point marked by a 2" iron pipe, said point being on the North line of the Archibald M. Harrison Donation Land Claim; thence North 77° 25' 06" West along the North line of the Archibald M. Harrison Donation Land Claim for a distance of 1327.24 feet to a point marked by an iron bar; thence North 87° 03' 50" West along the North line of the Archibald M. Harrison Donation Land Claim for a distance of 718.66 feet more or less to the point of beginning, containing 82.941 acres, rore or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
