## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That M. P. CARKUFF

of Route 2, Sheridan , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Deer Creek

a tributary of South Yamhill River

for the purpose of

irrigation

under Permit No. 14436 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 17, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.175 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW & SE & SW & as projected on Peter Carlyle D.L.C. No. 64, Section 13, Township 5 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toons—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.2 acres in  $SW_{4}^{1}$ ,  $SW_{4}^{2}$ , as projected on Peter Carlyle D.L.C. No. 64 4.8 acres in  $SE_{2}^{1}$ ,  $SW_{4}^{2}$ , as projected on Peter Carlyle D.L.C. No. 64 Section 13

Township 5 South, Range 6 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Situated in Yamhill County, State of Oregon, and bounded as follows to wit: Beginning at a point 5 rods S of SW cor. of Section 13 in T. 5 S., R. 6 W., W. M., in said Yamhill County, State of Oregon; thence running N. along said Section line between Sections 13 and 14 in Township and Range 85 rods; thence E. to center of the county road; thence southerly along the center of said county road to a point 5 rods S. of the S line of said Section 13; thence W. 160 rods to place of beginning and containing 80 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
