CERTIFICATE OF WATER RIGHT

This Is to Certify, That HENRY VAN GRUNSVEN

of Route 2, Forest Grove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of West Fork Dairy Creek, a tributary of Tualatin River, for the purpose of irrigation under Permit No. 16864 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 25, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.44 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 17, Township 1 North, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

18.6 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$
16.4 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 17

Township 1 North, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Part of the E $\frac{2}{3}$ of the SE $\frac{1}{4}$ of Section 17 T 1 N R 3 Will. Mer., beginning on the East line of the Charles Conklin D L C No. 53, in said township, at a stone which is 20.50 chas. west and 9.85 chs. north of the S E corner of Section 17, and running S 89 Deg. 33' East 17.74 chs. to an iron corner in the center of a roadway; thence N. 0 Deg. 10' East along said roadway 19.32 chs. to a stone and continuing to the center of the west fork of dairy creek 20.02 chs. more or less, from said iron corner; thence up said creek following the meanders to the east line of said claim; thence along said claim line S 0 Deg. 47' West 22.25 chs. more or less, to the place of beginning, containing 38.84 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
