This Is to Certify, That LESTER H. LAPSON

of Route 2, Albany , State of Gregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Santiam River

a tributury of Willamette River

for the purpose of

irrigation
under Permit No. 1801? of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from May 8, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.138 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NET NET, Section 23, Township 10 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-sightieth of one cubic foot per second per sere. It is equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

A description of the place of use under the right hereby confirmed, and to which such right is appurtment, is as follows:

land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning 17.30 chains South of the quarter section corner in the North boundary of section 23 in Township ten South of Range three West of the Willamette Meridian, Oregon and running thence East parallel with the North line of said Section 23, 31.hlp chains to the left bank of the Santiam River; thence Southeasterly up the left bank of said river to the East line of said Section 23 at the meander corner on the left bank of said River; thence South 1.50 chains to the North line of the Donation Land Chain of Geo. Knox; thence West 30.71 chains to the Northwest corner of said Claim; thence South 12.10 chains to the South line of the North half of said Section 23; thence west along the South line of the North half of said Section 11.34 chains to the center of the Sounty road leading to Jefferson; thence North 39° West along said road 12 chains; thence North 16° West 11 chains; thence East 22 chains to the place of beginning, containing 82.49 acres, more or less, all in Line County, Oregon, together with the protable irrigation equipment and orchard duster now situated on the above described real property and used thereon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
