a tributary of Tualatin River

for the purpose of

irrigation under Permit No. 17998 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 6, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes cforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.375 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN 1 E & NE 1 N 4, as projected on Wm. Scroggins D.L.C. No. 60, Section 20, Township 1 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenent, is as follows:

0.6 acre in NE NE as projected on Wm. Scroggins D.L.C. No. 60
