CERTIFICATE OF WATER RIGHT

This Is to Certify, That VESTA BARNARD

of Star Route, nox 70, Prospect., State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek

a tributary of Rogue River

for the purpose of

irrigation

under Permit No. 15265 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from 1912 1. 1912

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.025 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW SEL, Section 9, Township 32 South, Range 3

East, V. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{12}$ acre feet or acre for each acre irrigated during the irrigation season of each year, from April 2, to October 31,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in SW4 SE4 Section 1

Township 33 South, Range 2 East, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

all that part of the SW¹/₄ of SE¹/₄ of Section 1, Township 33 South, Range 2 East, Willamette Meridian, lying North and West of the centerline of the Crater Lake Highway, as now constructed, said centerline extending from a point on the west line of the SW¹/₄ of SE¹/₄ of Section 1, said township and range, approximately 1159.3 feet south of the Northwest corner of the SW¹/₄ of SE¹/₄ of Section 1, said township and range, in a north-casterly direction across the SW¹/₄ of SE¹/₄ of said Section 1 to a point on the North line of said SW¹/₄ of SE¹/₄ of said Section 1, which is North 89° 50¹ east approximately 820.3 feet from said Northwest corner of said SW¹/₄ of SE²/₅ of said Section 1; said tract containing 7½ acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
