This Is to Certify, That PERL L. BYE

of Rouse 2, Box 290-A, Silverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Pudding River a tributary of Molalla River

for the purpose of

irrigation under Permit No. of the State Engineer, and that said right to the use of said waters 17297 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 30, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.148 cubic foot per second.

or its equivilent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET NET, as projected on Wesley Shannon D.L.C. No. 52, Section 6, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

Section 6

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.7 acres in SE_4^1 NE_4^2 , as projected on Wesley Shannon D.L.C. No. 52 2.1 acres in NE4 NE4, as projected on Wesley Shannon D.L.C. No. 52

Township 7 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Commencing on the North line and South 89° 23' West 14.65 chains from the most Easterly Northeast corner of the Donation Land Claim of Wesley Shannon and wife in Twp. 7 S. R 1 W of the W.M.; thence South 13.12 chains; thence North 70° East 3.70 chains to the center of Pudding River; thence meandering said Pudding River up stream along the center of same to where the Salam to Silverton road crosses said river; thence South 61° 20' West along the center of said road 15.80 chains; thence North 4.22 chains; thence South 69° 18' West 10.725 chains; thence North 20.05 chains to the Northeast corner of a hundred (100) acre tract of land owned by and akhawa as the Elvin Herr property; thence North 8.25 chains along the east line of a 81.15 acre trace of land owned by Charles E. Schubert, to the North line of the Wesley Shannon D.L.C.; Thence North 80° 23' East 12.13 chains along the North line of said claim, to the place of beginning, and containing 19.85 acres of land, more or less, and situated in Marion County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
