CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ALBERT SCHARER**

of Route 5, Box 383, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River a tributary of Molalla River for the purpose of irrigation under Permit No. 18206 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 8, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.183 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on L. N. English D.L.C. No. 67, Section 24, Township 7 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 2.6 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on L. N. English D.L.C. No. 67 Section 13
 - 11.2 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on L. N. English D.L.C. No. 67
 - 0.8 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on L. N. English D.L.C. No. 67 Section 24
- Township 7 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at an iron pin in the East line of Levin N. English Claim in Marion County, Oregon, at a point which is North 19° 45' East 800 feet from the Southeast corner of said D.L.C.; thence North 70° 15' West at right angle with said East line 837 feet; thence South 19° 45' West 369 feet to an iron pin; thence North 73° 7' West 646 feet to an iron pin on the East bank of Pudding River; thence continuing said line 22 feet to the center of said Pudding River; thence following the center of said Pudding River in a Northeasterly direction to a point where the center of said river intersects the East line of said D.L.C.; thence South 19° 45' West along said East line 1600 feet to the place of beginning, and being a part of the Levin N. English D.L.C. No. 57 in Township 7 South, Range 1 West, and Claim No. 67 in Township 7 South, Range 2 West of the Willamette Meridian in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
