CERTIFICATE OF WATER RIGHT

This Is to Certify, That **PETER W. SANDOZ**

of **Trail**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **two springs** a tributary of **an unnamed gulch, Elk Creek, and Rogue River** for the purpose of **irrigation, supplemental irrigation, domestic and stock use** under Permit No. **18592** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 6, 1948**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.034 cubic foot per second, being 0.024 c.f.s. from East Spring (No. 1), and 0.01 c.f.s. from West Spring (No. 2), and being 0.024 c.f.s. for irrigation and 0.01 c.f.s. for domestic and stock,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 5, Township 33 South, Range 1 East, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **4 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season from April 2 to October 31 of each year, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre in primary irrigation
3.0 acres in supplemental irrigation
Domestic and Stock use
all in the **NE $\frac{1}{4}$ SE $\frac{1}{4}$**
Section 5

Township 33 South, Range 1 East, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Deed Records of Jackson County, Volume 22, Page 374, copied in part as follows: The S 1/2 of the **NE $\frac{1}{4}$ Section 5**. Volume 224, Page 113. That portion of the **NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ lying East of the county road and being 3 acres in the Southeast corner of the said forty acre tract in Section 5 all in Township 33 South, Range 1 East, Willamette Meridian in Jackson County, Oregon.**

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
