of Route 1, Box 216, Gold Hill , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Rogue River a tributary of

for the purpose of

irrigation under Permit No. 18605 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 13. 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 SE1, Section 24, Township 36 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 12 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.65 acre in NW4 SE4 Section 24

Township 36 South, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by

applicant as follows:

Commencing at the Northwest corner of Lot 7 of Riverside Subdivision as shown on the amended and recorded plat thereof, and running thence South 19° East 181 feet to the Northerly right of way line of the Pacific Highway No. 99; thence along said right of way line North 51° 59° East 211 feet; thence running North 38° 01° West 190 feet to the Southerly bank of Rogue River; thence Southwesterly along said bant, 155 feet more or less, to the point of beginning, all situated in Section 24, Township 36 South, Range 4 West of the Willamette Meridian, in Jackson County, Oregon.

Subject to the effect of said premises being included within the Gold Hill Irri-

gation District.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
