## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That CORNELIUS BATESON

of Route 5, Box 382, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Pudding River a tributary of Molalla River

for the purpose of

irrication under Permit No. 1869h of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from 1819 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW SE 3, as projected on L. N. English D.L.C. No. 67, Section 13, Township 7 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre in  $SE_{\frac{1}{4}}^{\frac{1}{4}}$  as projected on L. N. English D.L.C. No. 67 16.6 acres in  $SW_{\frac{1}{4}}^{\frac{1}{4}}$  as projected on L. N. English D.L.C. No. 67

Section 13
1.3 acres in NW4 NE4, as projected on L.N. English D.L.C. No. 67
Section 24

Township 7 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

The Southeast quarter of that certain Donation Land Claim, known and described in the United States Government Surveys as the Donation Land Claim #57, of L. N. English, situate in Sections Eighteen and Nineteen, Township Seven South, Range One, West of the Willamette Meridian and No. 67 in Sections Thirteen and Twenty four, Township Seven South, Range Two, West of the Willamette Meridian, said Quarter containing 160 acres of land, more or less, Except all road and roadways....

EXCEPTING THEREFROM the following property, to-wit: "Beginning at the Southeast Corner of that Certain D.L.C. known and described in the United States Surveys as D.L.C. No. 57 of L.N. English situated in Sections 18 and 19, Township 7 South Range 1 West of Willamette Meridian, and No. 67 in Sections 13 and 21, Township 7 South, Range 2 West of the Willamette Meridian, running thence North 19° 45 East along the East line of said D.L.C. 2100 feet to the intersection of said East line with the center of Pudding River, thence up stream following the meandering of the center of said Pudding River to the intersection of said river with the south line of said D.L.C., thence east along said South line 460 feet to the point of beginning, containing 63.7 acres, more or less"

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
