CERTIFICATE OF WATER RIGHT

This Is to Certify, That GLENN O. INGLES

of Route 1, Box 223, Forest Grove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Gales Creek a tributary of Tualatin River for the purpose of irrigation under Permit No. 18711 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.625 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on A. Knighton D.L.C. No. 46, Section 35, Township 1 North, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acre in NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on A. Knighton D.L.C. No. 46
13.8 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on A. Knighton D.L.C. No. 46
Section 35
1.8 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on A. Knighton D.L.C. No. 46
2.0 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on A. Knighton D.L.C. No. 46
32.1 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on D. Allen D.L.C. No. 47
Section 34

Township 1 North, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Commencing at the SE cor. of the David Allen DIC in Sec. 34, T. 1N, R. 4W, W.M., Washington County, Oregon, and running thence N5°13' W 1344.3 feet to a point; thence S89°57' W 1767 feet to the center of the County Road; thence S26°12' E. following the center of said road 539 ft. to a point; thence S 20°25' E. along the center of said road 910.8 ft. to the Base Line; thence E. on the Base Line 1333.5 ft. to the place of beginning, containing 47.08 acres.

ALSO:

Commencing on the Base line at the SW cor. of Sec. 35, T. 1N, R. 4W, W.M., and running thence N. along the western line of the Amon Knighton DIC to a point approximately 350.0 ft. S. of the re-entrant cor. of said DIC; thence E. to the center of Gales Creek; thence following southerly and easterly with the meanderings of said Gales Creek in the center thereof to the northerly cor. of land belonging to the Bush Estate said point being in the southern portion of the A. Knighton DIC; thence southwesterly following the line of the Bush estate to the intersection of the Base line; thence W. to place of beg., containing 20.0 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
