**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That ROY E. AND CORA B. HUFFMAN**

of **Route 1, Box 298, Cave Junction**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Brown's Slough** a tributary of **East Fork Illinois River** for the purpose of **irrigation** under Permit No. **18793** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **June 22, 1949**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.40 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NW $\frac{1}{4}$  SW $\frac{1}{4}$** , Section 30, Township 39 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-fiftieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **3 $\frac{1}{2}$  acre feet per acre** for each acre irrigated during the irrigation season from April 1st to November 1st of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**18.0 acres in NE $\frac{1}{4}$  SE $\frac{1}{4}$   
2.0 acres in SE $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 25**

Township 39 South, Range 8 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Beginning at a point which is 19 chains north of the Southwest corner of Donation Land Claim #42, in Township 39 South, Range 8 West of the Willamette Meridian, and run thence North along the West line of said claim a distance of 17.4 chains, thence North 81 degrees East 13.12 chains to a point in the center line of a County Road, this point being on the section line between Section 25, Township 39 South, Range 8 West of the Willamette Meridian, and Section 30, Township 39 South, Range 7 West of the Willamette Meridian, thence along the center of said county road due South for a distance of 4.4 chains, thence along said county road South 23 degrees East a distance of 13.5 chains, thence South 81 degrees West 18.8 chains to the point of beginning, containing 26 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
