CERTIFICATE OF WATER RIGHT

This Is to Certify, That WASHINGTON COUNTY FLAX GROWERS

of Cornelius , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualstin River

a tributary of Willamotte River

for the purpose of

irrigation under Permit No. 18775 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 2, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.618 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 SE4, as projected on S. Emerick D.L.C. No. 46, Section 4, Township 1 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.2 acres in SW1 NE1, as projected on S. Emerick D.L.C. No. 16
1.8 acres in SE1 NE2, as projected on S. Emerick D.L.C. No. 16
1.6 acres in SE2 NW2, as projected on S. Emerick D.L.C. No. 16
1.8 acres in NE2 SW2, as projected on S. Emerick D.L.C. No. 16
11.0 acres in NE2 SE2, as projected on S. Emerick D.L.C. No. 16
20.0 acres in NW2 SE2, as projected on S. Emerick D.L.C. No. 16

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Co., Ore., thence N. along the center of said county road 437.4 ft. to the N. line of said Claim; thence W. along the N. line of said Claim 25.96 chs. to a point; thence S. 21.85 chs. to a point; thence E. 13.29 chs. to a point; thence S. 5° 08° E. 1.22 chains; thence E. 12.50 chs., thence N. 26° E. 2.10 chs., thence E. to the center of the Tualatin R., thence following the center line up said R., as it was in the year 1906 to where the same intersects the S. line of Claim No. 46, T. 18., R. 3W., W.M.; thence E. on the S. line of said claim to a point which is due S. of a point 40 chs. W. of the NE cor. of the said Emerick DIC; thence N. to a point in the center of the Tualatin R., which point is 40 chs. W. and 23.29 chs. S. of the NE Cor. of said DIC; thence up said river with all the meanderings thereof to the SW cor. of
