This Is to Certify, That GEO. SPIESSCHAERT AND F. A. VANAKEN

of Route 1, Forest Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

an unnamed stream a tributary of Dairy Creek

for the purpose of

irrigation under Permit No. 18900 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 15, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.185 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWA NWA, as projected on Orus Brown D.L.C. No. 71, Section 30, Township 1 North, Range 3 West, W. M.; NWA NEA, SWA NEA, and SEA NEA, as projected on Orus Brown D.L.C. No. 40, Section 25, Township 1 North, Range 1 West, W. M.

North, Range I. West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.2 acres in NW1 NW1, as projected on Orus Brown D.L.C. No. 71 1.6 acres in SW1 NW1, as projected on Orus Brown D.L.C. No. 71 Section 30

0.2 acre in NW2 NE3, as projected on Orus Brown D.L.C. No. 40
4.8 acres in SW3 NE3, as projected on Orus Brown D.L.C. No. 40

Township 1 North, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at a point on the N. line of Orus Brown DLC distant W. 44.60 chs. from the NE cor. thereof; running thence W. 14.22 chs. to a stone the angular corner on the N. line of said DLC; thence S. 0° 17' W. 22.93 chs. to the N. line of a tract of land owned March 2nd, 1877 by David Smith; thence N. 89° 22' E. on such line 14.89 chs., thence N. 1° 26' W. 22.77 chs. to the place of beginning, and containing 33.25 acres, more or less, said land being in T 1 N, R 4 W, W.M.

Excepting therefrom the following tract: Beg. at an iron pipe at the most northerly NW cor. of the Orus Brown and Lavina Brown DIC #10 in T 1N, R. hW, W.M., said point being the NW cor. of tract conveyed to Gertrude Crop by deed recorded in Book 117, page 99, Deed records of Washington County, Oregon; thence E. 292.3 ft. to a point in the county road; thence S. 0° 17' W., crossing an iron pipe 20.0 feet, a distance of 296.65 feet to an iron pipe; thence W. 292.3 feet to an iron pipe on the W. line of said Crop tract and thence N. 0° 17' E. 296.65 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
