## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That JOHN SEDERCRIST

of Route 1, Banks , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of West Fork of Dairy Creek, unnamed creek, and an unnamed spring a tributary of Tualatin River for the purpose of

irrigation, domestic use for one family and stock under Permit No. 19212 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 10, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.460 cubic foot per second, being 0.394 c.f.s. from West Fork Dairy Creek, 0.053 c.f.s. from unnamed creek, and 0.003 c.f.s. from spring for irrigation; and 0.01 c.f.s. from unnamed creek for domestic use and stock,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the N2 NE4 from West Fork Dairy Creek; SW4 NE4 from from unnamed creek; SE4 NE4 from spring, all being within Section 9, Township 2 North, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

From West Fork Dairy Creek:

6.5 acres in Nel Nel 1.6 acres in NW Nel 2.2 acres in SW Nel 18.2 acres in SE4 Nel 18.2 acres in SE4 Nel 18.2 acres in SE4 Nel 2.2 acre

From unnamed creek:

O.4 acre in SWA NEA Domestic and stock in SWA NEA 3.8 acres in SEA NEA

From spring:

0.2 acre in SE4 NE4

all being within Section 9 Township 2 North, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beg. at the SE cor. of the NE<sup>1</sup><sub>4</sub>, Sec. 9, T. 2 N., R. 4 W., W.M., and running thence N 80 rods; thence W 80 rods; thence N to the center of middle channel of Dairy Cr., thence up thru center of said Cr. to its intersection with the line running N & S thru center of said Sec. 9; thence S to center of Sec. 9, thence E 160 rods to place of beg. ALSO: Beg. at the SW cor. of the NE<sup>1</sup><sub>4</sub> NE<sup>1</sup><sub>4</sub> of Sec. 9, T. 2 N., R. 4 W., and running thence N. on W boundary of the above described tract 7.57 chs. to the center of Dairy Cr., thence down said Cr. to the S. boundary of said tract; thence W 13.70 chs. to the place of beg., together with that portion of the State H/W conveyed by the State H/W Comm. to George D. Saxton and wife by deed recorded July 24, 1944 on

book 233, page 109 Deed Records and excepting from said premises that portion thereof within the boundaries of the State H/W as described in Deed Record April 21, 1939 on book 180, page 35 Deed Records, and deed recorded February 2, 1942, book 205, page 599, Deed Records.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
