## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That SISTERS OF ST. MARY

of 200 St. Mary's Avenue, Beaverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaverton Creek, (sometimes known as Beaverdam Creek)

Beaverton Greek, (sometimes known as beaverdam Groek)
a tributary of Davison Greek, tributary of Tualatin River,

for the purpose of

rrication under Permit No. 19355 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from rech 20. 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.173 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the lot 4 (NE SE ), Section 8, Township 1 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres in Lot 4 (NE 2/4 SE 2/4)
10.6 acres in Lot 4 (SE 2/4 SE 2/2)
Section 8
Township 1 South, Range 1 West, W. H.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Beg. at the SW Cor. of the G.W. Elliott DIC No. 42 T. 1 S., R. 1 W., thence on the E. line of the John Elliott DIC No. 41, S. 21° 30' W.20.35 chs. to the NW cor. of a 10-acre tract sold by the above named Grantors, thence S. 21°30' E. 13.57 chs. to the NE cor. of a tract heretofore conveyed by the above Cwamtors to the above named grantoes, thence S. 10.04 chs., thence S. 81°30' E. 11.12 chs. to the SW cor. of a 5 acre tract heretofore conveyed by said Grantors to ploom, thence N. 25.30 chs. to the S line of said Glaim No. 42; thence N. 69° 30' W. 21.39 chs. to the place of beg., being part of Sections 8, 9, 16 and 17, T. 1 S., R. 1 W.
