under Permit No. 19680 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 19, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.215 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NM4 NM4, Section 30, Township 6 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to cne-eightieth of one cubic foot per second per acre, or its quivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at the Southwest corner of the Northwest quarter of the Northwest quarter of Section 30 in Township 6 South, Range One East of the Willamette Meridian in Marion County, Oregon; thence North 10 degrees 25' West 20.15 chains to an iron bar; thence South 61 degrees 13' East 22.06 chains to the center of the County Road; thence South 10 degrees 10' West along the center of said road 11.20 chains to an iron bar; thence North 89 degrees 30' West 7.00 chains to the point of beginning, and containing 22.11 acres of land in Section 25 in T 6 South, Range One West and in Section 30 in T 6 South, Range One East of the Willamette Meridian, Marion County, Oregon.

Save and except one acre, more or less heretofore sold by the grantors herein to Kenneth R. Olsen and Macyle C. Olsen, his wife, dated the 8th of May 1913, and recorded on page 671, Volume 295, Marion County, Oregon records of deeds,

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
