## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That JACK E. MALONE

of Route 1, Box 191, Ashland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Toleran Creek and a spring

for the purpose of

a tributary of Neal Creek domestic use for one family and irrigation

under Permit No. 19735 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates froguly 31, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.015 cubic foot per second, being 0.005 c.f.s. from spring for domestic use, and 0.01 c.f.s. from creak for irrigation,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW SW Section 13, Township 39 South, Range 1

East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited tone—eightlieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed he acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, and shall be still further limited to a diversion of not to exceed 0.01 c.f.s.,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at a point on the southeast right of way line of the Crowson Road, which point is 13 chains East and 8.04 chains South of the Northwest corner of Donation Land Claim No. 54 in Township 39 South Range 1 East of the Willamette Meridian in Jackson County, Oregon; thence South 59° 15' East 380 feet to the center line of Toleman Creek; thence along said line North 30° 45' East 45 feet; thence North 1° 56' east 105.43 feet to the Northeast corner of that tract conveyed to Easley; thence along the Southwesterly line of said tract North 39°29' West 265 feet to the Crowson Road right of way; thence along said road South 50°04' West 239.60 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
