CERTIFICATE OF WATER RIGHT

This Is to Certify, That **B. R. STOCKING**

of Route 1, Box 265-B, Rogue River, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Evans Creek

a tributary of Rogue River for the purpose of irrigation

under Permit No. 19881 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 12, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.005 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $W\frac{1}{2}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 4, Township 36 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in $W\frac{1}{2}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$
 Section 4
 Township 36 South, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at a point on the east line of the West half of the Northeast Quarter of the Northwest Quarter of Section 4, in Township 36 South, Range 4 West of the Willamette Meridian in Jackson County, Oregon, said point being 697.0 feet North of the Southeast corner thereof; thence North along said east line 155.0 feet; thence West 261.0 feet, more or less, to the easterly line of the County Road; thence Southerly along said easterly line, a distance of 155.0 feet, more or less, to a point West of the point of beginning; thence East 263.0 feet, more or less, to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
