This Is to Certify, That EUGENE F. MC CORNACK

of Route 4, Box 89, Hillsboro , has made proof State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tralatin River

a tributary of Willsmette River

for the purpose of

irrigation under Permit No. 19853 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 19, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.75 cubic feet per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is

appurtenant, is as follows:

18.0 acres in NE¹/₄ NE¹/₄, as projected on J. Lingenfelter D.L.C. No. 49 0.6 acre in Lot 5 (NE¹/₄ NE¹/₄)

9.0 acres in SE4 NE4, as projected on J. Lingenfelter D.L.C. No. 49 7.4 acres in Lot 6 (SE4 NE4)

6.2 acres in NE4 SE4, as projected on J. Lingenfelter D.L.C. No. 49 0.5 acre in Lot 7 (NE4 SE4)
