## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That J. A. JAROSS

of Route 3, Box 207, Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of MCKay Creek

a tributary of Dairy Creek, a tributary of Tualatin River, irrigation for the purpose of

under Permit No. 19861 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 25. 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.164 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SM_{\perp}^{1}$  NEL, as projected on Wm. Jolly D.L.C. No. 74, Section 24, Township 1 North, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres in SW1 NE1, as projected on Wm. Jolly D.L.C. No. 74 5.1 acres in SE2 NE2, as projected on Wm. Jolly D.L.C. No. 74 2.6 acres in NE2 SE2, as projected on Wm. Jolly D.L.C. No. 74 0.1 acre in NW2 SE2, as projected on Wm. Jolly D.L.C. No. 74 Section 24

Township 1 North, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Part of the Wm. Jolly DLC No. 74 in Sec. 24, T 1N, R. 3W., W.M., in Washington County, Oregon, and more particularly described as follows: Beg. at a point in the center of County Road #271, which beginning point bears S 89° 42' W 1504.0 ft. and N 0° 25' E 671.4 feet from the SE cor. of the Wm. Jolly DLC, No. 69 in Sec. 19, T 1N, R 2W, W.M., and from which beginning point an iron pipe bears N 86° 46' E 26.6 feet. Running thence N 86°46' E 114.8 feet to an iron pipel thence N 5° 39' E 162.5 feet to an iron pipo; thence N 71° 35' E 64.4 feet to an iron pipe; thence N 36° E 515.0 feet to an iron rod; thence N 9° 28' E 257.0 feet to an iron pipe on the left bank of McKay Greek; thence continuing N 9° 28' E 20 ft. to a point in the center of said creek; thence downstream in the center of McKay Greek, with all its meanderings thereof, to its intersection with the center of said County Road #217 (the approximate courses and distances along the center of said creek are as follows: N. 71° 30' W 147 feet, N 54° 50' W 190 feet, N 25° 35' W 102 feet, S 30' E 162 feet, N 8° E 68 feet N 76° 40' W. 65 feet, S 52° W 233 feet, S 37° W 152 feet, S 8° 30' E 106 feet, S 5° W 125 feet, S 30° W. 358 feet, S 5° E. 192 feet, S 67° 30' E . 180 feet, and S 22° 45' W 143 feet to a point in the center of said road); thence S. 33° 10' E along the center of said road 142.4 ft. to an angle in same; thence S 0° 25' W 23.6 feet to the place of beginning, containing 11.85 acres, more or less.

First Tract: Commencing at the SE cor. of the Masonic Cemetery in Sec. 24, T. 1 N.,

R. 3 W., thence S. 75° E. 5.50 chs., to an old dead yew tree on the W bank of the creek; thence N 22° E 3.80 chs., more or less, to the ME cor. of the old sawmill; thence S. 87° 30' W 2.00 chs., thence S. 52° 30' W 5.31 chs. to the place of beginning, containing 1.79 acres, more or less, and being set a part for mill purposes; also water privilege thereto belonging.

Second Tract: Commencing at the SE cor. of the Masonic Cemetery in Sec. 24, T. 1 N., R. J W., thence W. until it intersects Adalina Jane Ireland's line; thence S-casterly along said line to the creek; thence up the main channel of the creek to the SE Cor. of the Mill plat; thence along the said mill plat to the place of beginning, containing h acres, more or less.

Third Tract: Commencing at a post in the center of the County Road Leading from Hillsboro to Glencoe on the line between the land of E. F. McNalley and said Silas Bennett and N 85° 30' W (mag. var. 20° E) 2.16 chs. from the S.W. cor. of the Masonic Cemetery in Sec. 24, T. 1 N., H. 3 W., in Washington Co., Oregon; thence S. 46° 30' E. 12.22 chs. to a post in the County Road; thence N. 16°30' E. 2.66 chs. to the S line of land formerly owned by B. O. Thorne; thence N 57° 30' W on said line 11 chs., thence N 85° 30' W 27 links to the place of beginning, containing 1.61 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
