CERTIFICATE OF WATER RIGHT

This Is to Certify, That AL G. WILSON

of **Route 1, Box 370, Gold Hill**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Rogue River** a tributary of **Pacific Ocean** for the purpose of **irrigation**

under Permit No. **20259** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **March 14, 1951**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.01 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 26, Township 36 South, Range 4 West, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-fortieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **$\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**0.3 acre in SE $\frac{1}{4}$ SW $\frac{1}{4}$
0.2 acre in SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 26**

Township 36 South, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Beginning at the NE corner of DEC # 37 in T. 36 S., R. 4 W., W. M., Jackson County, Oregon; thence South, along the East line of said claim a distance of 157 feet to the North line of Highway #99; thence westerly, on a curve with a radius of 533.69 feet along the northerly right of way line of said highway a distance of 90.27 feet; thence South **16° 57' west 10 feet**; thence North **73° 03' West** along the northerly line of said highway a distance of 105.41 feet; to the intersection with the north and south center line of Sec. 26, said Township and Range; thence continue along said northerly right of way line of the highway, North **73° 03' West** a distance of 257.32 feet; thence North **16° 57' East** a distance of 67 feet to the Southerly bank of Rogue River; thence South **88° 23' 43" East** along said river bank a distance of 375.33 feet to point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
