CERTIFICATE OF WATER RIGHT

This Is to Certify, That F. H. BOWLEY AND SONS

of Route 2, Box 235, Cornelius , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Tualatin River a tributary of Willamette River

for the purpose of

irrigation under Permit No. 20078 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 16, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.966 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW1 NE1, Section 14, Township 1 South, Range 3

West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at a point on the E line of Sec. 14, T. 1 S., R. 3 W., W.H., Washington County, Oregon, 180 feet S of the NE cor. thereof said point being the SE cor. of a tract of land conveyed to Everett Dunnette by deed recorded in book 251 page 409 Deed Records Washington County, Oregon, thence S along the east line of Sec. 14, 30.85 chs. more or less to the N line of the Francis DeWitt DIC., thence S 88° W along the N line of said DIC 27.85 chs. more or less to the E line of a roadway described in Deed Records book 126 page 99 Deed Records Washington County; thence N along the E line of said roadway 30.85 chs. more or less to the SW cor. of said Everett Dunnette tract which point is 300 feet south of the N line of said Sec. 14, thence Easterly along the S line of said Everett Dunnette tract to the place of beginning.
