CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ELMER E. AND MAMIE E. ROSS**

of **Route 3, Box 231, Hillsboro**, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **McKay Creek** a tributary of **Tualatin River** for the purpose of **irrigation** under Permit No. **20286** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **April 17, 1951**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.111 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NW $\frac{1}{4}$ SW $\frac{1}{4}$** , as projected on John Pool D.L.C. No. **60, Section 18, Township 1 North, Range 2 West, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre in NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on John Pool D.L.C. No. **60**
2.4 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on John Pool D.L.C. No. **60**
6.4 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on John Pool D.L.C. No. **60**
Section 18

Township 1 North, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Beg. at a point on the S. boundary of Jacob Hoover DLC #38 in Sec. 18, T. 1 N., R. 2 W., W.M., in Washington County, Ore., the said beg. point being 88.4 ft. N. 87°45' W. from the SE cor. of said Hoover DLC, being also the NW cor. of Lot 15 of Glence Acres (now vacated) and running thence S 0°13' W. 721 ft., thence S. 87°38' E. 677 ft., thence S. 0°45' W. 1126.64 ft. more or less to the SE cor. of the tract of land formerly owned by F.M. and G.C. Lichenthaler, thence N. 87°38' W. 968 ft. more or less to the corner of McKay Creek, thence up the center of said creek with the meanders thereof to a point directly S. of a point on the N. line of the William Jolly DLC, 787 ft. N. 87°45' W. of the place of beginning; thence N. 50 ft. more or less to the N. line of said Jolly DLC, thence S. 87°45' E. 787 ft. to the place of beginning in the County of Washington, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
