**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That SAMUEL T. JONES**

of Route 1, Box 540, Gold Hill, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River a tributary of \_\_\_\_\_ for the purpose of irrigation under Permit No. 20298 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 23, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 16, Township 36 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acres in SW $\frac{1}{4}$  SW $\frac{1}{4}$   
Section 16  
Township 36 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning from the quarter section corner common to Sections 16 and 21 in Township 36 South, Range 3 West of the Willamette Meridian in Jackson County, Oregon; running thence North on the North and South center line through said section 16, 95.0 feet to the Northerly line of the Pacific Highway; thence along said Highway line North 76° 02' West 2213.6 feet to the place of beginning. And running thence along the said Highway North 76° 02' West 240.0 feet, thence North 14° 7' East 181.1 feet to the Southerly line of the Southern Pacific Railroad Right of Way, thence along said railroad line So. 76° 11' E. 240.0 ft. Thence So. 14° 07' W. 181.1 ft. to the place of beginning. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
