CERTIFICATE OF WATER RIGHT

This Is to Certify, That **WALTER W. LIGHTNER**

of 1944 S. Highway 99, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Rogue River** a tributary of _____ for the purpose of **irrigation** under Permit No. 20359 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **May 23, 1951**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.01 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in **the Lot 7, (NW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 21, Township 36 South, Range 5 West, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **1 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**0.8 acre in NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 21**

Township 36 South, Range 5 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Commencing at the SE corner of Lot 3 of Orchard Beach Tracts thence; southwesterly along the present road 30 feet; thence northerly and parallel with the easterly line of said Lot 3 to Rogue River, thence easterly along Rogue River to the NE corner of said Lot 3, thence southerly along the easterly line of said Lot 3 to the point of beginning, being a part of Tract 3 of Orchard Beach Tracts, a subdivision of a portion of the SE $\frac{1}{4}$ of Section 21, in Township 36 S., Range 5 W., W.M., Oregon, according to the plat of said subdivision on file and of record in the office of the County Clerk of Josephine County, Ore.

ALSO: Tract 2 of "Orchard Beach Tracts" a subdivision of a portion of Sec. 21, T. 36 S., R. 5 W., W.M., Ore. according to the plat of said subdivision on file and of record in the office of the County Clerk of Josephine County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
