CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. F. WIKOFF

of Route 6, Box 353 B, Salen , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unmassed stream

a tributary of Little Pudding River

for the purpose of

irrigation
under Permit No. 13772 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from May 26, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.183 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE\(\frac{1}{2}\) Section 9, Township 7 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at the corner to Sections 9, 10, 15, and 16 in Township 7 South of Range 2 West of the Willamette Meridian in Marion County, Oregon and from thence running North 89° 30' East along the South boundary of Section 10, 7.27 chairs to an iron pipe; thence North 28.87 chains to an iron pipe in the North boundary of that certain tract of land conveyed to A. C. Suhre by deed of conveyance recorded at page 139 of Vol. 218 of the Deed Records for Marion County, Oregon; thence North 81° 38' West 13.55 chains to the Northeast corner of said tract of land; thence South 30.26 chains to an iron pipe set in the South boundary of said Section 9 at a point which is 6.22 chains South 89°30' West from the place of beginning; thence North 89° 30' East 6.22 chains to the place of beginning.

SAVE AND EXCEPT the following described property: Beginning at the corner of Sections 9, 10, 15, and 16, in Township 7 South, Range 2 West of the Willamette Meridian in Warion County, Oregon; thence Easterly 7.267 chains to an iron pipe; thence Northerly 11.06 chains to an iron pipe; thence Westerly 9.043 chains to an iron pipe; thence Southerly 11.06 chains to the section line between Sections 9 and 16 thence Easterly 1.776 chains to the place of beginning. RESERVING ALL ROADS AND ROADWAYS.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
