CERTIFICATE OF WATER RIGHT

This Is to Certify, That **CECILIA ENGELGAU**

of **Route 1, Box 1, Troutdale**, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a group of four springs, tributary of Beaver Creek Springs, a tributary of Sandy River, for the purpose of domestic use in residence and auto court and irrigation under Permit No. 16549 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 29, 1915

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.133 cubic foot per second, being 0.12 c.f.s. from North 2 springs for domestic use in residence and auto court, and 0.013 c.f.s. from South 2 springs for irrigation,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located at **North 2 springs: SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on D. F. Buxton D.L.C. No. 59, Section 25; 2 South springs: Gov. Lot #9 (SW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 25, all being within Township 1 North, Range 3 East, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet** per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.9 acre & domestic in Lot #5 (NW $\frac{1}{4}$ SE $\frac{1}{4}$)
0.1 acre & domestic in SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 25
Town: 1 North, Range 3 East, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: The following described real property situated in Section 25, T. 1 N., R. 3 E., W.M., in the County of Multnomah and State of Oregon, to-wit: Beg. at a point in the W. side of the County Road from Portland to the Sandy R. in Sec. 25, T. 1 N., R. 3 E., W.M., from which the SW cor. of a 50 ft. r/w described in a deed to Emanuel May, dated August 12, 1892, bears N. 5° 4' E. 81.84 ft. distant and running thence S. 50° 4' W. 421.6 feet to a corner; thence S. 47° 8' E. 312.5 ft. to the NW corner of the Pelton tract; thence N. 55° 49' E. 372 ft. to the W. side of the County Road; thence N. 37° 11' W. along the W. side of the county road 353.15 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
