This Is to Certify, That BERNY BROTHERS

of Route 1, Mt. Angel , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Apiqua Creek:

a tributary of Pudding River

for the purpose of

irrigation

under Permit No. 17640 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **Earch 27. 19**47

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW1 NW1, Section 21, Township 6 South, Range 1 West. N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per scre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.6 acres in NE1 SE1, as projected on Benjamin Cleaver D.L.C. No. 51 Section 9

2.0 acres in HW SW as projected on Benjamin Cleaver D.L.C. No. 51 0.4 acre in SW SW as projected on Benjamin Cleaver D.L.C. No. 51 Section 10

Township 6 South, Range 1 West, W. M.

Iand on which water is to be used is a part of that more explicitly described by applicant as follows: Commencing 2.99 chains South of the quarter Section stone between Sections 9 and 10 T. 6 S., R. 1 W. of the Willamette Meridian, Marion County, Oregon; thence West 26.33 chains; thence South 13.93 chains; thence South 83 degrees East 30.79 chains to the middle of the County Road leading from Mt. Angel, to Silverton; thence North 30 degrees East 1.05 chains; thence North 20 degrees East 17.30 chains; thence West 11.00 chains to the place of beginning, and containing 542 acres, more or less, all situate in T. 6 S., R. 1 W. of the Willamette Meridian, Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
