CERTIFICATE OF WATER RIGHT

This Is to Certify, That EUGENE HAMRICK

of Route 6. Box 150. Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Little Pudding River a tributary of Pudding River

for the purpose of

irrigation
under Permit No. 1992, of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from April 17, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.188 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL SWL, Section 26, Township 7 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiet; of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.4 acres in Lot 3 (NE¹/₄ SW¹/₄)
9.4 acres in NW¹/₄ SW¹/₄
1.6 acres in SW¹/₄ SW¹/₄
0.6 acre in Lot 4 (SE¹/₄ SW¹/₄)

Section 26 Township 7 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows: Beginning at the quarter section corner between Sections 26 and 27, in Township 7 South, Range 2 West of the Willamette Meridian, in Marion County, Oregon; and running thence North 89° 45' East 25.95 chains to the West line of John L. Eoff Donation Land Claim; thence south 0° 15' West along the West line of said Eoff's Claim 21.88 chains to the County Road; thence South 89° 30' West 25.76 chains along the center of said County Road; thence South 53° West 4.65 chains to the East line of the Benjamin Walden Donation Land Claim; thence North 0° 15' East along the East line of said Walden Claim 24.67 chains; thence East 3.41 chains to the place of beginning, containing 64.09 acres of land, more or less, in the Colman Burnett Donation Land Claim, in Township 7 South, Range 2 West of Willamette Meridian in Marion, County, Oregon save and except all roads and roadways.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
