CERTIFICATE OF WATER RIGHT

This Is to Certify, That GILBERT A. PERRIN

of 602 S. 2nd Street, Corvallis, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Santiam River a tributary of Willamette River for the purpose of irrigation under Permit No. E-82 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 14, 1909

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.313 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 15, Township 9 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $3\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Calvin Neal D.L.C. No. 47
21.8 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Calvin Neal D.L.C. No. 47
Section 11

Township 9 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the NW corner of the D.L.C. of Calvin Neal; thence along the North boundary line of said claim 15.92 chains; thence South 34.075 chains; thence North-west 16.46 chains to center of county road and the West boundary line of said D.L.C.; thence Northeast along the boundary line of said Claim 34.075 chains to the place of beginning, all being in Sections 11 and 14, T. 9 South, Range 2 West of the Willamette Meridian, Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
