## CERTIFICATE OF WATER RIGHT

## This Is to Certify, Thapped N. and Pearl G. Robertson

of Route 2, Box 460, Grants Pass , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean

for the purpose of

irrigation
under Permit No. 15134 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from rebruary 24, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWL, Section 36, Township 35 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31 of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.0 acres in NW<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>, as projected on D. L. C. No. 37 11.0 acres in NE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>, as projected on D. L. C. No. 37 Section 36

Township 35 South, Range 7 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 425.3 feet North of the Southeast corner of DC #37 in Township

35 South Range 7 West of the Willamette Meridian Oregon, thence running North 425.3

feet; thence West 3033.6 feet to Rogue River; thence Southeasterly along the bank of

Rogue River to a point due West of the point of beginning; thence East 2965 feet to

the point of beginning. Containing 30.48 acres more or less. Beginning at the Southeast corner of DC #37 in Township 35 South Range 7 West of the Willamette Meridian,
Oregon thence running North 425.3 feet; thence West 2965 feet to Rogue River thence
Southwesterly along the bank of Rogue River to a point due West of the point of beginning, thence East 3200 feet to the point of beginning. Containing 31.33 acres,
more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
