## CERTIFICATE OF WATER RIGHT

okoute 1. Box 260. Aumsville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

an unnamed stream and an unnamed spring attributary of Beaver Creek, a tributary of Willamette Ri

for the purpose of

domestic use for one family and irrigation under Permit No. 16121, of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 14, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.058 cubic foot per second, being 0.01 c.f.s. for domestic from spring, and 0.048 c.f.s. from stream for irrigation,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL SEL, as projected on Duff Kimsey D.L.C. No. 49, Section 8, Township 8 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.2 acres in SEt SWt, as projected on Duff Kimsey D.L.C. No. 49
Domestic & 1.6 acres in SWt SEt, as projected on Duff Kimsey D.L.C. No. 49
Section 8

76.40 acres of land; more or less.

Township 8 South, Range 1 West, W. H.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the North East Corner of the Donation Land Claim of Duff Kimsey and wife, in Township 8 South, Range 1 West of the Willamette Meridian, Marion County, Oregon; thence North 63 degrees West 25.17 chains along the North line of the Duff Kimsey Claim to the middle of the County Road; thence South 20 degrees 46' West 18.99 chains along the middle of the County Road; thence South 67 degrees 58' West 5.673 chains along the middle of the County Road; thence South 10.68 chains; thence East 34.50 chains to the East line of the Duff Kimsey Claim; thence North 19.00 chains to the place of beginning, and containing
