CERTIFICATE OF WATER RIGHT

This Is to Certify, That. GEORGE K. GOODRICH, D.D.S.

of Route 1, Box 374, Medford , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hartley Creek and Goodrich Reservoir constructed under App. No. R-21310, Per. No. R-830 a tributary of Griffin Creek and Bear Creek for the purpose of

irrigation under Permit No. 16712 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 3, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.138 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL SEL, Section 10, Township 38 South, Range 2 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year from direct flow and storage from reservoir constructed under Permit No. R-830; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in NEt SEt Section 10 9.6 acres in NWt SWt Section 11 Township 38 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 864.60 feet East and 1906 feet North of the corner common to sections 10, 11, 14, and 15 in Township 38 South Range 2 West of the Willamette Meridian, and running thence East 990.00 feet; thence North 537.90 feet; thence West 2950.20 feet; thence South 537.90 feet; thence East 1947.00 feet to point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
