CERTIFICATE OF WATER RIGHT

This Is to Certify, That ARION D. CHRISTENSEN

of Star Rt. 1, Box 79, Jacksonville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Big Applegate River a tributary of Rogue River for the purpose of irrigation under Permit No. 19116 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 28, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.124 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 29, Township 38 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.75 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 23
Township 38 South, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:
Government Lots 2 and 3 in Section 23, Township 38 South, of Range 4 West of the Willamette Meridian in Jackson County, Oregon; also, beginning at the Northeast corner of Donation Land Claim No. 38, in Township 38 South of Range 4 West of the Willamette Meridian in Oregon; thence South 15 1/2° West 4 chains and 66 links; thence South 41° West 6 chains; thence South 54 1/2° West 10 chains; thence South 80° West 8 chains to a post near the confluence of Humbug Creek with Applegate Creek thence South 45 3/4° East along the West bank of Applegate Creek 29 chains and 59 links to the Southeast corner of said D.L.C. 38; thence North along the east boundary line of said D.L.C. 38, 36 chains and 85 links to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
