## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That JULIUS WINTERFIELD

of Banks , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Two unnamed streams

a tributary of West Fork of Dairy Creek

for the purpose of

irrigation
under Permit No. 13797 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 3, 1939;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.80 cubic foot per second, being 0.3125 cubic foot per second from north stream and 0.1875 cubic foot per second from south stream,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NE_{4}^{1}$ ,  $NE_{4}^{$ 

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

The  $NE_4^1$  of Section 33 and  $SW_4^1$   $NW_4^1$  of Section 34, Township 2 North, Range 4 West, W. M., except those certain tracts deeded to the Gales Creek and Wilson River Railroad Company as described in Deed recorded in Book 110, Page 79, Records of Washington County, Oregon, and subject to rights of way for public roads, as same now exist over and across said property.

NOTE: This certificate confirms a change in place of use of water approved by an Order of the State Engineer entered May 16, 1951, pursuant to the provisions of Section 116-606, O. C. L. A., and supersedes Certificate of Water Right heretofore issued to Julius Winterfield and recorded at Page 15090, Volume 12, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
