CERTIFICATE OF WATER RIGHT

This Is to Certify, That SMITH BROTHERS

of Glendale, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Cow Creek a tributary of Umpqua River for the purpose of Irrigation under Permit No. 5364 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 9, 1922;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 19, Township 32 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.0 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$
4.0 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$
5.3 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$
17.9 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 30,
T. 32 S., R. 5 W., W. M.

NOTE: This certificate is issued to confirm a change in point of diversion and place of use of water approved by an order of the State Engineer entered May 28, 1951, pursuant to the provisions of Section 116-606, O. C. L. A., and said certificate, together with certificate recorded at Page 20236, Volume 14, State Record of Water Right Certificates, supersedes Certificate of Water Right heretofore issued to Smith Brothers, and recorded at Page 8601, Volume 8, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
