CERTIFICATE OF WATER RIGHT

This Is To Certify, That BADGER IMPROVEMENT DISTRICT

of Wamic , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Badger Creek and Badger Lake Reservoir constructed under Permit N o. R-773 a tributary of White River

irrigation, supplemental irrigation, domestic and stock use under Permit No. 15165 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 21, 1929

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually bereficially used for said purposes, and shall not exceed 24.0 cubic feet per second, being 12.06 c.f.s. from Badger Creek for irrigation; 11.80 u.f.s. from Badger Lake Reservoir for supplemental irrigation; and 0.14 c.f.s. from Badger Creek for domestic and stock use,

or its equivalent in case of rotation measures at the point of diversion from the stream. The point of diversion is located in the SW4 NE4, Section 32, Township 3 South, Range 11 East, N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of open-conductance parameter not to exceed one acre foot per acre during any 30-day period up to July 1st of each year and not to exceed 3 acre feet per acre during any irrigation season; provided, that the rate of flow shall not exceed one-fortieth of a second foot per acre up to July 1st of each year and thereafter not to exceed one-eightieth of a second foot per acre, except in case of rotation; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
