a tributary of Ditch Creek

for the purpose of

domestic use for two families

under Permit No. 17991 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 15, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_4^1 NE_4^1 , Section 19, Township 2 North, Range 10 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ---- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriators as follows:

Deed Record 29 Page 73 Beginning at the Southeast Corner of the SE_{4}^{1} , of Section 18 Twp. 2 North Range 10 East WM; running thence West and parallel with the Section 101 rods $3\frac{1}{2}$ feet to a point on the Section line; thence North parallel with the section 53 rods to a point; thence East 61 rds and $3\frac{1}{2}$ feet to a point; thence North parallel with the Section line 27 rods to a point; thence East 40 rods to a point on the Section line between Sections 17 and 18 thence South 80 rods to the place of beginning.

ALSO:

Deed Record 33 Page 143 Beginning at the Corner common to Sections 17, 18, 19 & 20, in Twp. 2 North Range 10 East WM which is a rock marking the Northeast Corner of tract hereby described; thence North 87° 29' W. 7.4 chains along the Section line between said Sections 18 & 19 to a dogwood post marking the Northwest Corner of the Tract hereby described; Thence South 2° 31' West along the West boundary of the orchard 13.51 chains to an oak post marking the Southwest corner of the tract hereby described; thence South 87° 29' East parallel with the North boundary of Section 19 7.99 chains to the East boundary of Section 19 to an oak post marking the Southeast Corner of the Tract hereby described; thence North 13.51 chains along the East line of said section 19 to the place of beginning. Containing 10 Acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
