

CERTIFICATE OF WATER RIGHT

This Is to Certify, That BEN HILTON

to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of irrigation

for the purpose of

under Permit No. 19028 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 19, 1949

that the amount of water to which such right is entitled and hereby confirmed, . the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed O.ll cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in 350 Section 18, Section 18, Township 36 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightioth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed la acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.0 acres in Lot 2 (SW $\frac{1}{4}$ SE $\frac{1}{4}$) 4.0 acres in Lot 3 (SE $\frac{1}{4}$ SW $\frac{1}{4}$) Section 18

Township 36 South, Range 6 West, W. M. Land on which water is to be used is a part of that more explicitly described by appro-

priator as follows: Beginning at a point which bears West 377.3 feet from the East 1/4 corner of Section 18, Township 36 South Range 6 West of the Willamette Meridian, thence South 395.7 feet to the County Road; thence North 82° East 380 feet; along Road; thence south 417 feet; thence South 88° West 937 feet; thence South 49°24' West 173 feet; thence South 38° 31' West 456.5 feet; thence South 69° 31' West 591 feet; thence South 38°43' West 582 feet; thence South 75°25' West 618 feet to a point on the Southerly line of Lot 3 of said Section 18; thence Northwesterly along the Southerly line of said lot 3 to the Southwest corner of said Lot 3; thence North 1518 feet; thence West 700 feet; thence North 156 feet; thence East 3583 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
