## CERTIFICATE OF WATER RIGHT

This Is To Certify, That RAYMOND H. AND RALPH E. BAPKER

of state of satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

a Sharards Gulch drainage canal Snake River

for the purpose of

under Permit No. 18133 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 19, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 cubic foot per second,

or its equivalent in case of rotation. measured at the point of diversion from the stream. The point of diversion is located in the SE4 NW4, Section 14, Township 16 South, Range 47 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed la acre feet per acre for each acre irrigated in any 30-day period prior to June 1st, 1 acre foot per acre for each acre irrigated in any 30-day period after June 1st and shall be still further limited to a total diversion of not to exceed 3 acre feet per acre for each acre irrigated during any irrigation season, and shall also be limited to the water available at the proposed point of diversion, and shall not carry with it the right to compol the continuance of the water; provided further that the amount of water allowed herein, together with the amount secured under any other right existing and shall not exceed the limitation allowed herein, conform to such reasonable. Totation system as may be ordered by the proper state officer.

Lard on which water is to be used is a part of that more explicitly described by appropriator as follows:

All that part of the northwest quarter of the northwest quarter of section fourteen, township sixteen, south or range forty-seven east of the Willamette Meridian described as follows, to wit: Beginning at the northeast corner of the northwest quarter of the northwest quarter aforesaid and running thence west on the north line thereof to the northwest corner of said northwest quarter of northwest quarter; thence south along the west line of said northwest quarter of northwest quarter a distance of twenty rods; thence in a southeasterly direction to a point on the east line of said northwest quarter of northwest quarter which is sixty rods south of the place of beginning; thence north along said east line to the place of beginning, containing twenty acres, more or less, also the south half of the south half of the south half of the southeast quarter of the southeast quarter of Section ten, township sixteen, south of range forty-seven east of Willamette Meridian, containing five acres, more or less, also the north twelve and one-half acres of the northeast quarter of the northeast quarter of section fifteen, township sixteen, south of range forty-seven east of Willamette Meridian.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
