CERTIFICATE OF WATER RIGHT

This Is to Certify, That VICTOR CHRISTENSEN

of Route 1, Box 259, Sherwood, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Saum Creek a tributary of Tualatin River for the purpose of irrigation under Permit No. 19944 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 25, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.41 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 25, Township 2 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.0 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$
5.4 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$
14.4 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 25

Township 2 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the quarter section corner on the east boundary line of Section 25, Township 2 South, Range 1 West of the Willamette Meridian, and running thence south on the East boundary line of said Section 20 chains; thence North 89 deg. 32' west 52.50 chains, thence North 20 chains, thence South 89 deg. 32' east 52.50 chains to the place of beginning, containing 105 acres, excepting therefrom that tract of land described in Deed Book 103, page 498 (b) and that certain easement described in Deed Book 103, Page 130 Deed Records of said County and State

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
