CERTIFICATE OF WATER RIGHT

This Is To Certify, That LEWIS W. KILBOURN

of Route 2, Box 222, Central Point, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River, a tributary of Pacific Ocean, for the purpose of irrigation under Permit No. 20159 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 2, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.077 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 13, Township 36 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.15 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 13
Township 36 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point where the westerly right of way line of the Table Rock Road intersects the North line of the Roguelands Irrigated Orchard Tracts, now City of Medford from Camp White, Deed Book 324 P 241; said beginning point being a 6" x 6" concrete monument with brass plate inscribed U.S. Engineer's Boundary monument, said beginning being S 25°23'27" E on U. S. Engineer's bearings a distance of 4929.76 feet from the North East corner of D.L.C. No. 42 in Township 36 South, Range 2 W. Willamette Meridian, in Jackson County, Oregon.

From this beginning point thence N 18°24' W 478.41 feet along the westerly right of way line of Table Rock Road to a 1" iron pipe on the bank of the Rogue River, thence following the left bank of the Rogue River in a southwesterly direction to a point where it intersects the east line of the City of Medford property, thence following the boundary line of the City of Medford property to the point of beginning as follows; S 0°08'12" E 427.31 feet to a 6" x 6" concrete monument; thence N 83°28'36" E 21.55 feet to a 6" x 6" concrete monument; thence N 70°12'41" E 510.49 feet to a 6" x 6" concrete monument; thence N 76°03'48" E 623.97 feet to the point of beginning, containing 10.7 acres more or less. This deed is written to more fully describe that property recorded in Jackson County Deed Records Book 297 P 169 and is one and the same property.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
