CERTIFICATE OF WATER RIGHT

This Is to Certify, That IE ROY E. WILLIAMS

of Route 1, Box 82, Ashland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unpamed stream & Reservoir constructed under App. No. R-27493, Per. No. R-1403 a tributary of Bear Creek, a tributary of Rogue River, for the purpose of irrigation and supplemental irrigation under Permit No. 21640 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 25, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.138 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE_4^1 NW_4^1 , Section 30, Township 38 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed by acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1403, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 69.80 chains North of the Southwest corner of Donation Land Claim No. 42, in Township 38 South, of Range 1 East of the Willamette Meridian, Oregon; thence North 17.30 chains along the West boundary line of said Donation Land Claim; thence East 21 chains; thence South 20.80 chains to Northerly side line of County Road; thence North 80 deg. 30. West 21.30 chains along Northerly line of County Road; to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
