CERTIFICATE OF WATER RIGHT

This Is to Certify, That S. O. CORRELL

of Baker, State of Oregon, has a right to the use of

the waters of Sutton Creek, a tributary of Powder River for Tract No. 1 and Powder River, a tributary of Snake River, for Tracts Nos. 2, 3 and 4 for the purpose of irrigation of 278 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1908 for Tract No. 1; 1880 for Tract No. 2; 1883 for Tract No. 3; and April 24, 1885 for Tract No. 4;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/10th of one cubic foot per second per acre.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
